PROJECT OVERVIEW

The Municipality of Thames Centre requires a qualified, experienced electrical contractor to provide labour, equipment, materials, fuel, transportation and all that is necessary for the installation of the second phase of a walking path lighting system at Dorchester Park, with this second phase consisting of 26 LED light fixtures on concrete poles, as per specifications to be provided in the tender documents. No variances from required specifications will be accepted. Ideally this project will be completed by the end of November 2021.
