

THAMES CENTRE SPORTS WALL OF FAME

OBJECTIVE

To honour and recognize those athletes from Thames Centre who have achieved honour and recognition through sport at the Olympic and/or professional level.

SELECTION CRITERIA

Eligibility of Athlete

In order for an athlete to be considered for admission to the Sports Wall of Fame they must compete or have competed on a national or international level that is recognized professionally and/or recognized by the International Olympic Committee (I.O.C.) Selections criteria must include all the following:

- **1. Experience**: Must have played or competed in their sport at the professional or Olympic level.
- **2. Local Impact**: Must have been born in or spent their formative years in the Municipality of Thames Centre.
- 3. Achievements: Notable accomplishments at a national or international level.
- **4. Recognition:** Acknowledgment by a professional organization and/or the Olympic Committee (I.O.C)

THAMES CENTRE SPORTS WALL OF RECOGNITION

New for 2025, the Municipality will be adding a sports wall of recognition at the FlightExec Centre and Thorndale Lions Community Centre. These walls will allow local minor sports associations to recognize their successes.

Definition of Athlete

For the purposes of the Thames Centre Sports Wall of Fame, a Thames Centre athlete shall be:

- a) Anyone born in The Municipality of Thames Centre who spends his/her formative years here, or
- b) Anyone who is not born here, but who comes to this Municipality and over an extensive period of time, proves their athletic ability in the Municipality of Thames Centre. Said athlete may be considered even if they eventually moves away from the Municipality.

NOMINATION PROCESS

Nominations may be submitted by athletes, media and any member of the community with an interest in Sport. Nominators are encouraged to supply as much supporting detail as possible while completing the nomination. The Committee may obtain any additional research and validate the factual basis of each submission.

The total number of inductees per Induction Ceremony to the Sports Wall of Fame shall be a maximum of six (6) inductees.

All eligible inductee nominee applications which are not selected for the induction may be reconsidered each year thereafter. The Committee may contact the nominator for additional information in subsequent years.

In all cases of nominations rejected by the Committee, letters will be sent to the nominator by the Committee, explaining the procedure and asking if there is any additional information that may be relevant to help with the nomination process.

All nomination files will be kept for any historical information that they may contain - no files will be destroyed.

No sitting member of the Committee shall be considered for election into the Thames Centre Sports Hall of Fame.

The Thames Centre Sports Hall of Fame Committee reserves the right to review and make changes to the selection criteria as deemed necessary. All decisions of the Selection Committee will be final.

INDUCTION CEREMONY

Each newly elected member of the Thames Centre Sports Wall of Fame shall be formally inducted at an official induction, held every other year on even years, only.

ADMINISTRATION

Administration of the Thames Centre Sports Wall of Fame, including record keeping and actual site determination, will be provided by the Thames Centre Sports Wall of Fame Committee.
