Purpose and Effect

The purpose and effect of this Application is a request to allow the expansion of a legal non-conforming use to facilitate the construction of an addition onto an existing single detached dwelling located within the Environmental Protection (EP) Zone. The applicant wishes to construct a 46.45 square metre (500 ft²) addition to be located on the north side of the dwelling. This request is being sought since residential uses are not permitted within the Environmental Protection (EP) Zone.

Description and Location of Subject Land

The subject property is legally described as North Part of Lot 14, Concession 4, NRT (geographic Township of North Dorchester), Municipality of Thames Centre. The subject property is located on the south side of Marion Street, east of Elgin Road (County Road 73).
