The 2019/2020 Reduce Impaired Driving Everywhere (RIDE) Grant Program Agreement was entered into on June 24, 2019, which covers a period from April 1, 2019 and ending March 31, 2020. The Municipality has been granted \$8,853.00 to enhance the regular RIDE program to offset costs for officers' overtime and paid duty.

a) Thames Centre Police Survey Results.

Members discussed results of the Thames Centre Community Police Survey that was posted on the Municipal Website and Facebook Page from May 1, 2019 to July 31, 2019. The survey had a total of 223 responses and was circulated to members on August 15, 2019, in advance of this meeting.

Members commented that overall the survey results showed that residents were mostly satisfied with the quality of service provided by the Ontario Provincial Police in the Municipality of Thames Centre

The majority of respondents were from the 36 – 50 year old age group at 38.6 %.

Members agreed that the main concerns from residents were from Theft from Vehicle, Theft from Residence/Business and Traffic and Road Safety,

The Detachment Commander provided that the survey was helpful and has been shared with officers and if there is a community concern to let OPP know.
