 - **Surface.** The TCDDPAC is going to look into an engineered mulch, which will create less maintenance for the park;
 - **Fencing.** The TCDDPAC deliberated different ideas of what other dog parks use for fencing, which will be safe for all dogs;
 - **Policies.** It was verbally discussed that the TCDDPAC will need to come up with a policy regarding cleaning up after one's dog;
 - Water Services. It was brought forward to the TCDDPAC that water may be a good idea to have at the park. In the end, it was decided that most dog owners bring their own water bottles and this will not be needed;
 - Sponsorship. The Subcommittee is going to look into creating a sponsorship package for those who are wanting to donate. The Director of Community Services and Facilities is going to confirm the exact price, with mulch, to assist the Subcommittee with sponsorship;
 - Hours of Operation. The hours of operations are dawn until dusk. There will be no additional lighting added to the dog day park; and
 - **Signage.** One sign will be designated to sponsorship and one sign will have the rules, hours and policies for the park.
