# **APPLICATION FOR CONSENT (B7/21)**

## APPLICANT: Canadian National Railway Company AGENT: Denton's Canada LLP (c/o Andrea Paterson) LOCATION: South side of Minnie Street and west of the CN Railway Crossing ROLL NO.: 3926-000-080-12600

## Purpose and Effect

The purpose and effect of this application is to sever a parcel of land declared surplus to the needs of the Canadian National Railway for lot addition purposes. The lands to be conveyed would have a frontage of approximately 15.2 metres (49.9 ft) along Minnie Street and an area of approximately 3250 square metres (34982.1 ft<sup>2</sup>) to be merged in the same name and title as the property containing Lind Lumber. The lands to be conveyed are separated by the Lind Lumber property by an untraveled portion of the Minnie Street road allowance. The lands to be retained include an active railway line.

# **Description and Location of Subject Land**

The subject property is legally described as Part of Lots 1 to 7, Concession 3, NRT, Part Road Allowance, Concession 4 NRT, Part of Lots 8 to 14, Concession 5 NRT, Part of Lots 14 to 18 on Plan 128, and Part of closed Bruce Street (geographic township of North Dorchester), Municipality of Thames Centre. The subject lands are located on the south side of Minnie Street and on the west side of the Railway crossing.
