REGARDING AN OFFICIAL PLAN AMENDMENT TO IMPLEMENT THAMES CENTRE'S FIVE-YEAR OFFICIAL PLAN REVIEW

TAKE NOTICE that the Municipality of Thames Centre will hold a virtual open house and virtual public meeting to provide an opportunity for public input in relation to proposed changes to the Thames Centre Official Plan resulting from the five-year Official Plan review. At the <u>Virtual Open House</u>, staff will provide an overview of the Discussion Papers representing five (5) key themes which includes recommendations for changes to the Thames Centre Official Plan. Those themes include Housing, Employment, Agriculture, Natural Heritage and Climate Change. The public will be offered an opportunity to provide feedback and ask questions. At the <u>Virtual Public Meeting</u>, staff will also provide an overview of the Discussion Papers and recommendations for changes to the Thames Centre Official Plan. There will also be an opportunity for questions and comments by Council and members of the public.

Changes to the Official Plan are being proposed to ensure conformity with the County of Middlesex Official Plan and consistency with the Provincial Policy Statement. Due to the large geographic extend and wide distribution of land potentially affected by the proposed Amendment, no map of these areas is provided with this notice. There are no other applications which affect the entire Municipality of Thames Centre.

APPEAL PROCEDURES:

If a person or public body would otherwise have an ability to appeal the decision of Council for the County of Middlesex to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Thames Centre or the County of Middlesex before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Municipality of Thames Centre before the proposed official plan amendment is adopted, the person or public body does not make oral submissions at a public meeting, or make written submissions to the Municipality of Thames Centre before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
