Dorchester Road & Thorndale Road Crosswalks

Council approved the installation of a crosswalk on Dorchester Rd, where the current painted crossover is, to be installed no later than Aug 31, 2023 and the installation of a crosswalk on Thorndale Rd, to be installed once a location has been determined. Funds for this project will come from the 2023 Transportation Capital Reserve Fund



Phase 2 of Dorchester Inclusive Park

Council moved forward with issuing a request for proposal for Phase 2 of the Dorchester Inclusive Park and Donor Recognition Wall. Phase 2 will see the installation of equipment geared towards adults. This phase of the project will be funded by donations, sponsorships and grants received by a group of dedicated citizens known as the Dorchester Dream Park Committee. Phase 2 will include amenities shown below.

2023 Municipal Service Inventory and Strategic Plan

During the meeting, Council also:

- received a presentation from the Middlesex County Engineer on the Middlesex County Roads Department.
- received a staff report and heard public comments on a proposal for a gravel pit to be located at a
 property on the west side of Elgin Rd and south side of Dundas St. No decision was made as another
 report will come from staff at a future meeting.
- approved temporary seasonal outdoor patio at 2008 & 2135 Dorchester Road
- received a staff report and heard public comments on a proposal for a drive—thru restaurant & grocery store to be located at 2300 Dorchester Rd. No decision was made and a follow up report from staff will come to Council at the next meeting (July 17, 2023).
- approved temporary use and zoning amendment to permit an existing garage to remain on the lot to be severed for a period of up to one (1) year and to allow for residential development of the land at 5242 Marion St.
- approved a severance and rezoning of a surplus residence to a farming operation at 4128 Mossley Dr.
- denied an application to create a lot for industrial development and to create an access point and servicing easement at the end of Gerald Parkway on south side and the east side of Rebecca Rd.
- held a Committee of Adjustment meeting approving minor variance applications at 5299 Dorchester Rd, 3594 Mossley Dr and 177 Jennifers Trail.
