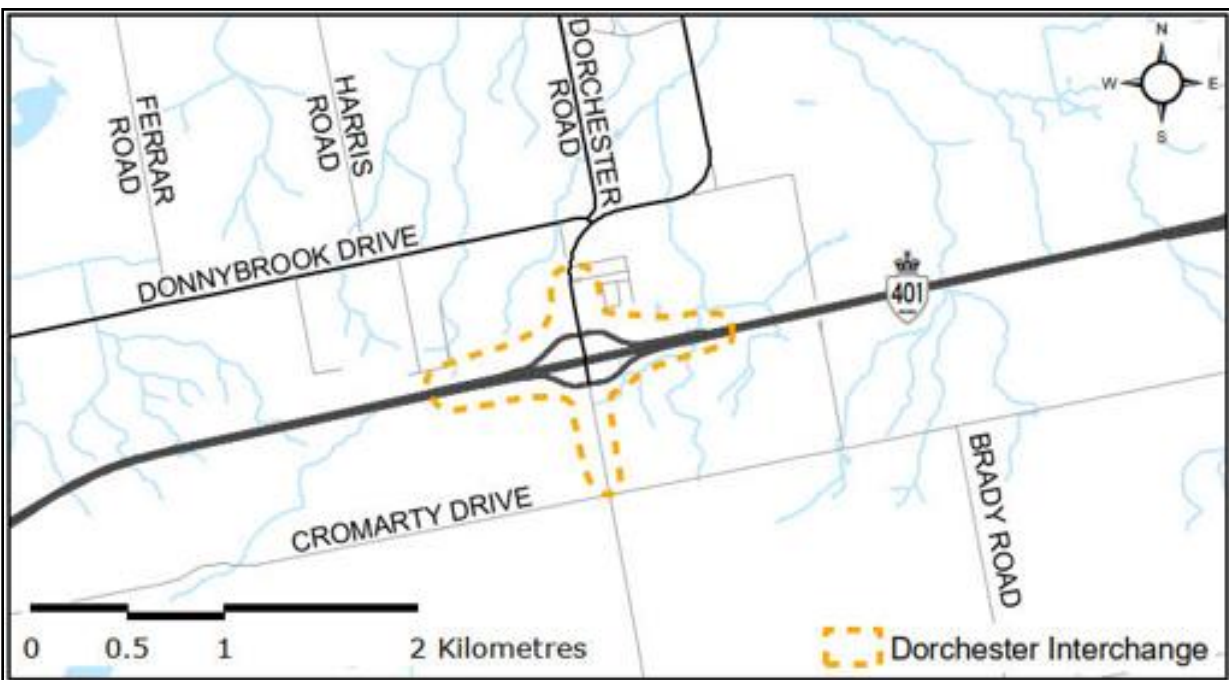


## NOTICE OF COMPLETION

### ***Highway 401/Dorchester Road Bridge Replacement and Interchange Improvements in the Municipality of Thames Centre, Middlesex County Detail Design and Class Environmental Assessment Study GWP 3053-11-00***

The Ministry of Transportation, Ontario (MTO) retained Green Infrastructure Partners Inc. (GIP) and Dillon Consulting Limited (Dillon) to complete Design-Build Contract 2022-3009, which includes the Class Environmental Assessment (EA), Detail Design and construction of the Highway 401/Dorchester Road Bridge Replacement and Interchange Improvements in the Municipality of Thames Centre, Middlesex County, as shown on the figure below. The project includes replacement of the bridge and reconfiguration of the interchange ramps.



This project has been completed in accordance with the *Class Environmental Assessment (EA) for Provincial Transportation Facilities (2000)* as a Group 'B' undertaking. Group 'B' projects are considered major improvements to existing transportation facilities. This project will build upon the previously completed Preliminary Design as documented in the Transportation Environmental Study Report (January 2016), which received Environmental Clearance in March 2017. It is anticipated that construction will begin in 2024.

In accordance with the MTO Class EA, a Design and Construction Report (DCR) has been prepared to document the study including environmental impacts and mitigation measures required for construction. The DCR will be made available for a 30-day comment period from **July 19, 2023 to August 19, 2023** on the Project Website [www.Hwy401Dorchester.com](http://www.Hwy401Dorchester.com). A hard copy of the DCR will not be provided at public review locations. If you wish to review the DCR and require an alternate format, please contact the Project Team to discuss review options.
