## Affordability of Water & Wastewater Systems

Rural and Small Urban Municipalities

Council supported Consent Agenda Item 10.2, advocating to the provincial and federal levels of government to make them aware that rural and small urban water and wastewater systems are financially unsustainable, and advocating to the Association of Municipalities of Ontario (AMO), the Rural Ontario Municipalities Association (ROMA) and the Federation of Canadian Municipalities (FCM) to examine the unaffordability of water and wastewater system operational costs is systemic provincially and nationally.
